Module 5 Summative Assessment Project

In this module, we learned about the Church's sacramental life.

Now you are going to explore a liturgical topic that relates to the sacramental life.

Objective

Research and write a five-paragraph essay about a liturgical topic related to the Seven Sacraments of the Church.

Content

- 1. Choose one of the following liturgical topics:
 - Paschal candle
 - holy water
 - · laying on of hands
 - anointing with oil
 - · chrism oil
 - vows and promises
 - Kyrie Eleison ("Lord, Have Mercy")
 - Gloria
 - Homily
 - · Prayer of the Faithful
 - Sanctus ("Holy, Holy")

- epiclesis (the invocation of the Holy Spirit over the gifts)
- Institution Narrative and Consecration
- anamnesis ("Do this in memory of me")
- · intercessions prayed during the Eucharistic prayer
- Doxology
- Lord's Prayer (Our Father)
- Rite of Peace
- Agnus Dei ("Lamb of God")
- Dismissal as related to the words Mass and mission
- 2. Find out what this liturgical topic is and how it fits into the sacramental life of the Church.
- 3. Explore the history of this liturgical action or prayer. Is this liturgical action or prayer found in Scripture? Why is this liturgical action or prayer preserved in the Sacraments of the Church?
- 4. Research how this liturgical action or prayer strengthens the Church as the Body of Christ.
- 5. Find a quote from a famous person reflecting on this liturgical action or prayer.
- 6. Describe how this liturgical action or prayer can relate to your life.
- 7. Watch the Summon Entertainment video "How To: Write a Paper" for tips on putting your essay together.
- 8. Summarize your findings in a five-paragraph essay.

Writing Assignment Requirements

- 1. Define the expectations.
 - a. Review the rubric for your paper.
 - b. Clarify the topic and develop the thesis statement, argument, or persuasive perspective.
 - c. Identify the format, length, and citation requirements.

2. Research.

- a. When searching the Internet, look for the most accurate and current information related to your topic.
- b. Use credible websites with reliable information.
- 3. Create an outline.
 - a. Develop your thesis statement.
 - b. Outline three to four points that will support your thesis statement.
 - c. Provide two to three supporting details for each point.
 - d. Outline *before* you begin writing! It is an easy way to see where you might be lacking in research or supporting details.
- 4. Write your rough draft.
 - a. Check that your first paragraph has a thesis statement.
 - b. Check that your other paragraphs each make a point supporting your thesis statement or argument.

5. Proofread.

- a. Check your paper for spelling and grammatical errors.
- b. Proofread again! Have a friend, family member, or another teacher read over your paper to check for spelling and grammatical errors. This person can also check for the clarity of your supporting details and the logical flow of your paper.
- 6. Create a draft of your bibliography or works cited as you research.
- 7. Write your final paper.
 - a. Make any suggested changes or modifications.
 - b. Check one more time to be sure you have followed the guidelines of the rubric. Attach the rubric to the paper if requested. Keep a copy of the rubric in order to review your grade and any comments against the requirements listed on the rubric.
